Theft

- 12-761 09-28-12 A Braeburn Road resident reported the theft of a large amount of jewelry. The complainant advised they noticed the jewelry missing a month ago, but were waiting to make sure it wasn't misplaced. Several people have been in the home in the past few months, including cleaning service and workmen. Detectives are investigating the incident.

Criminal Defacement

- 12-764 09-29-12 An Old Dundee Road resident reported spray painted graffiti on the roadway in front of her residence. The graffiti removal unit was contacted for removal.

Criminal Trespass to Land

- 12-703 09-07-12 A Plum Tree Road resident reported that someone had placed gravel from his driveway to the property east of his, using it for access to the property. The complainant's property is posted no trespassing. He further stated that he had placed concrete blocks, blocking the access and someone removed them. The complainant wanted the incident documented and forwarded to the Village for follow-up.

Driving Under the Influence

- 12-701 09-07-12 While running stationary radar on Route 62, an officer observed a vehicle swerve several times. In following the vehicle, the driver continued to swerve and brake for no apparent reason. A traffic stop was effected. The officer smelled a strong odor of an alcoholic beverage on the driver's breath. The driver was asked to complete field sobriety tests, and failed. He was placed under arrest and charged with improper lane use, DUI over .08 and no insurance. He was processed and released on bond. Case is pending a court appearance.
- 12-750 09-23-12 BHPD received 9-1-1 calls of a possible drunk driver westbound Route 68. In checking the area, the officers located the vehicle on Old Dundee Road. Officers smelled a strong odor of an alcoholic beverage on the driver's breath, who admitted drinking. The driver was driving on a revoked driver's license. The driver was arrested and charged with aggravated DUI, no insurance, improper lane use and driving while license revoked. He was processed and held for bond court. Case is pending a court appearance.

No DL / Suspended DL

- 12-699 09-06-12 An officer effected a traffic stop on River Road near Haegers Bend Road for speeding. In checking the driver's license, it was determined to be suspended. The driver was arrested and charged with speeding and driving on a suspended license. He was processed and released on bond. A court date is pending.
- 12-706 09-08-12 An officer observed a vehicle turn right on red against the sign at Route 62 and Route 59. A traffic stop was effected. In checking the driver's license, it was determined to be suspended. The driver was arrested and charged with DWLS and no right turn on red light. He was processed and released on bond. A court date is pending.
- 12-719 09-12-12 An officer observed a vehicle turn right on red against the sign at Route 62 and Route 59. A traffic stop was effected. The driver advised that his driver's license was suspended. The driver was arrested and charged with DWLS and no right turn on red light. He posted bond and was turned over to Hoffman Estates PD on an outstanding warrant. A court date is pending.
- 12-723 09-14-12 An officer responded to a one vehicle crash on Ridge Road / Merri Oaks. On arrival, the driver advised that her license was suspended. She was arrested and charged with failure to reduce speed to avoid an accident and DWLS. She was processed and released on bond. A court date is pending.
- 12-731 09-16-12 An officer effected a traffic stop on Bateman Road / County Line Road. The driver of the vehicle was driving without a valid license. He was charged with speeding and no valid license. He was processed and released on bond. A court date is pending.
- 12-732 09-17-12 An officer observed a vehicle on Route 62 west of Route 25 without a front license plate. In stopping the vehicle, it was determined that the driver had a suspended license. The driver was arrested and charged with a registration violation and DWLS. She was processed and released on bond. A court date is pending.

Harassment / Threats

- 12-756 09-27-12 A County Line Road resident reported that her daughter's husband had made threats against the family, stating that he would kill them all. The complainant did not want to sign a complaint; she was interested in obtaining an order of protection. The officer advised what she needed to do for the order of protection. No further action at this time.
- 12-759 09-27-12 A Sieberts Ridge Road resident contact BHPD to report receiving harassing phone calls. The complainant advised that a former employee continued to call after being told to stop. In contacting the offender, he advised that he is owed money and is trying to collect. The officer advised him the matter

is civil, he should contact an attorney and stop harassing the complainant or he could face charges.

Domestic

- 12-738 09-19-12 An officer took a station report of a delayed domestic that occurred on County Line Road while traveling through Barrington Hills. The victim stated that his son takes medication, and when he doesn't take it, he can become violent. He advised that they were driving home and his son became violent and started hitting and kicking him. The victim advised that when he arrived home, Algonquin Police were called to the residence. He did not want to press charges because his son does not act this way while on his medication. The McHenry County State's Attorney was contacted and declined to press charges. The victim was given a domestic violence handbook. No further action taken.
- 12-747 09-22-12 Officers responded to an Oak Knoll Road residence for a reported domestic battery in progress. On arrival, the wife was located outside by the driveway, the husband was at the front door and the 10 year old child was inside. The wife advised that she and her husband were arguing over his cell phone and his refusal to let her see some text messages. The wife stated that her husband then struck her. The wife struck the husband back. Neither party wanted to sign complaints; there was no visible sign of injury to either party. The husband agreed to leave the residence for the night and let things settle down. Domestic violence handbooks were given to both parties. No further action taken.

Assist Other Agency

- 12-726 09-14-12 Cook County requested an officer stand by at an Old Sutton Road residence while confiscating roosters that were possibly involved in fighting. No further action taken.

Civil Matter

- 12-704 09-07-12 An officer responded to an Old Sutton Road residence for an ongoing civil problem. The complainant stated that she had an order of protection/no contact order against a subject that boards his horse on the

property and she had received mail from him. The content of the mail was a notification that the court date had been moved up. The officer contacted the on call state's attorney who advised that since the subject is acting as his own attorney, no violation has been committed. No further action taken.

12-714 09-11-12 An officer met with a Merri Oaks Road resident at BHPD regarding ongoing issues with a neighbor. The complainant indicated that BHPD may "take sides". The officer advised the complainant that in no way would BHPD take sides, the ongoing issue is civil and will be treated as such.

12-754 09-27-12 An officer took a report from a subject reporting that he had not been paid for a hot tub that was shipped back in July. In contacting the resident (owner of the credit card), he stated that his credit card company had contacted him about the charge back in July and he advised that he did not make the purchase. His credit card company denied the charge and cancelled the card. He advised that the item had been shipped to Alsip. It is a civil matter between the company and the credit card company. No further action taken.

12-721 09-13-12 An officer responded to a Rub of Green Lane residence for a vehicle with the keys locked inside. Entry was gained.

They advised they were contracted with AT&T to contact people that were on the do not call list to advise them of upgrades AT&T was making to their system. The officers advised the subjects they were not allowed to solicit without a permit. The subjects agreed to leave the area. No further action taken.

12-716 09-12-12 A resident came into BHPD to turn in a watch that he found on Otis Road near Brinker Road. The watch was turned over to detectives for property storage. Case is pending owner identification.

Suspicious Circumstance

12-700 09-06-12 An officer responded to a Healy Road residence for a report of a suspicious incident and possible scam. The complainant stated that two subjects came to his home claiming to do foundation repair. They initially gave a very low quote, but when they started working, they stated it was going to be more. When the resident refused to pay them without having their identifiers and a written invoice, they left the scene. The officer checked the area, but was unable to locate the offenders.

- 12-713 09-11-12 An officer responded to an Old Sutton Road residence for a suspicious incident. The complainant stated that someone had knocked over a shelf and tossed around various supplies in her barn. It did not appear that anything was missing.

Unwanted Subject

On arrival, the complainant advised a female subject approximately 17 years old came to the back door and appeared very intoxicated. The female subject stated she was looking for someone she thought lived there. The subject left when she was told there was not anyone there by the name she had given. Officers checked the area, but were unable to locate the female subject.

The complainant stated that the landlords were on the property trying to gain access to the residence. The landlord stated that they had a court order stating that the tenant was supposed to place the treadmill outside for them to pick up. The tenant failed to comply. The tenant eventually put the treadmill outside and the landlords returned with an officer to retrieve it. No further action taken.
