**SUMMARY**  
**June 2012**

**TRAINING:**

**Criminal Trespass to Land**

- 12-466      06-17-12      A Brinker Road resident reported a female subject placed a flyer in her mailbox. The complainant advised that her home security video captured the incident and a copy of the incident was turned over to BHPD. The complainant was also advised to notify the post office for them to follow up on. No further action taken at this time.
- 12-477      06-22-12      An officer responded to a Barrington Bourne residence for a report of three subjects on ATV's being detained on his property. On arrival, the officer spoke with all parties involved. The complainant declined to sign complaints. He wanted the subjects warned to stay off his property. The officer spoke to the father of one of the boys and the owner of the ATV's; he was advised that the boys were not allowed to ride on private property without consent, including the Com-Ed property. No further action taken.
- 12-479      06-22-12      Com Ed contacted BHPD regarding a vehicle parked near their substation east of Jacqueline Lane. The complainant also advised that there is reportedly a "party area" south of the substation. In checking the area, the officer located two subjects coming out of the wooded area. In questioning them, the officer determined that they were coming from the "party area". The subjects showed the officers where it was located. The officers advised the subjects that they are trespassing on private property and any future visits to the location would result in arrests.

**Curfew Violation**

- 12-482      06-24-12      While conducting a premise check at the Presbyterian Church on Brinker Road, an officer observed four juveniles on the playground of the school. Officers drove all four juveniles home and spoke with their parents. No further action taken.

**Child Visitation Interference**

- 12-240      06-01-12      The complainant arrived at the BHPD parking lot for his schedule child visitation exchange. His former girlfriend never arrived with his children. In contacting the former girlfriend, she advised that they had a family function and she wanted the children with her. The complainant signed a complaint for Unlawful Visitation Interference. Case is pending a court appearance. No further action taken.
- 12-441      06-10-12      The complainant arrived at BHPD for the scheduled child visitation exchange. His ex-wife failed to bring his son. The officer contacted the ex-wife and she stated that there was a misunderstanding; she thought the schedule was

more flexible in the summer. She advised she would bring her son to BHPD right away. The exchange was made, no further action taken.

#### **Burglary from Vehicle**

12-470 06-20-12 A patron at the Country Club advised that she had locked her purse in her car. When she returned to the car, she discovered that the passenger window had been broken and her purse removed. No one was seen in the area. She had already contacted her credit card company to cancel her credit cards. No further action taken.

#### **Theft**

12-468 06-19-12 The General Contractor for a home under construction on Creekside Lane reported that two generators and two air conditioning units were taken from the construction site sometime overnight. No one was seen in the area. The items were entered into the Law Enforcement Agency Data System as stolen. No further action at this time.

#### **Credit Card Fraud**

12-422 06-02-12 A Windrush Lane resident reported that while she was vacationing in Ireland, someone obtained her credit card information and made several charges on her credit card. A report was made for documentation only; this is being investigated by her bank. No further action taken.

#### **Driving Under the Influence**

12-496 06-29-12 While on patrol, an officer observed a vehicle traveling at a high rate of speed and turn onto Old Sutton Road. The vehicle turned into the wrong lane. The officer affected a traffic stop. The officer smelled an odor of alcohol on the driver's breath. The driver failed all field sobriety testing and was placed under arrest for DUI. He was processed and released on bond. The case is pending a court appearance.

#### **Hit and Run**

12-435 06-08-12 A motorist called 9-1-1 to report that his vehicle had been struck while merging on Route 62 west of Brinker Road. His mirror was damaged. The offending vehicle continued to travel westbound with the complainant following. With the assistance of Algonquin PD, the vehicle and driver were detained in Algonquin. A report was completed and citation was issued. Case is pending a court appearance.

#### **Drag Racing**

12-489 06-26-12 While on patrol, an officer was flagged down advising him of a car crash on Chapel Road. On arrival, the officer observed a one car crash with two male subjects and a second vehicle stopped on the road. The driver of the

crashed car advised that a deer ran out in front of him and when he swerved to avoid it, he lost control. After further discussion, both subjects admitted that they were drag racing when the deer ran out. Both subjects were arrested and cited for racing. This case pending a court appearance, both subjects were released on bond.

#### **Suspended License / Registration**

- 12-443      06-10-12      While on patrol, an officer observed a vehicle disobey the no turn on red at Route 59 / Route 62. In stopping the vehicle, it was determined that the driver had a suspended license. The driver was arrested and charged with Driving While License Suspended, Operating a Vehicle without Insurance and Disobeying a No Turn on Red. The subject was given a court date and released on bond.
- 12-480      06-23-12      While on patrol, an officer observed a vehicle without a front license plate and affected a traffic stop. He determined that the driver was driving with a suspended license. The driver was arrested for Driving While License Suspended. He was given a court date and released on bond.

- 12-497      06-29-12      An officer responded to a reported vehicle on fire on Route 62 west of Brinker Road. The fire department was on scene and extinguished the fire. The vehicle was removed by a tow truck. No further action taken.

The Village building department was contacted and advised they are aware of the situation and are currently working with the tenant to get it resolved. No further action taken by BHPD.

### **Public Complaints**

12-436      06-09-12      An officer responded to an Old Sutton Road residence for a noise complaint. The officer was able to faintly hear the noise and advised the complainant that he did not feel it was excessive, but he would check the area to see if he could locate the source. The source was located at an Algonquin Road residence. The resident agreed to turn the music down slightly, but he did not think it was excessive. He advised he has the music on to drown out the traffic noise from Algonquin Road. The complainant advised that he did not want to sign a complaint. No further action taken.

12-476      06-22-12      A Donlea Road resident advised that his neighbor has been coming onto his property and mowing the grass that borders their common driveway. The complainant advised that he has asked his neighbor not to come onto his property. The officer also spoke with the offender and a third neighbor who advised that there is an ongoing civil case in court regarding the easements. The officer advised the complainant that since there is already an ongoing case, he would not allow a complaint to be signed. He advised a report will be made and charges can be pressed at a later date, if warranted. No further action at this time.

12-448      06-12-12      An abandoned ATV was found on a Rock Ridge Road resident's property. The ATV was towed. The owner was located and claimed the ATV. No further action taken.

12-430      06-06-12      An Otis Road resident is concerned about a male subject fishing on the private lake without permission. He stated that a row boat is being stored on the neighbor's property. Contact was made with the property owner, who stated he was unaware of anyone having permission, but would check with his partner and let BHPD know.

She had contacted Western Union and advised them not to accept any requests for money on her behalf and they requested a police report to document the incident. No further action taken.
