

Longmeadow Parkway Project Status December 2013- Phase One Approval July 2014- Completion of Value Engineering Study

- 12' lanes revised to 11'
- Open piers instead of closed piers
- Weathering steel design





Current Total Construction Cost -\$97 Million (for 5.6 mile corridor) -\$9 Million for Section D

Longmeadow Parkway Project Status

- Current- US Army Corps Permit Submittal; Land Acquisition process
 - Preliminary Plans Prepared



 Funding Status- \$97 Million construction cost;
 \$40 Million secured from IDOT; per KDOT "other sources coming online".

No connection proposed to Longmeadow Parkway; creation of cul-de-sac on Autumn Trail.





- Autumn Trail Pavement Section Comparison

	KDOT Proposed	Existing Pavement Section	Subdivision Ordinance (13-Lot Subdivision)
Aggregate	6"	13"	10" (or 6" BAM)
Binder	21/4"	-	-
Surface	11/2"	2"	2"

 Recommendation: Request 2" minimum surface thickness and 10" aggregate base course.

- Autumn Trail Construction Access
 - Request a note on plans: "Construction access to Autumn Trail cul-de-sac shall be from Longmeadow Parkway ROW only."


