Barrington Hills Country Club Forest Management Plan

Michael Donovan, Director of Agronomy at Barrington Hills Country Club, presented the tree preservation plan. Roughly 70 trees, mostly non-native, invasive Norway Maples, will be removed. Very few heritage trees will be removed, some sustaining damage due to storms or are dead. The project will take 1 to 3 years to fully implement. Kirsten Stewart, from Urban Forest Management of Fox River Grove, has also reviewed the plan and feels it aligns with the Village's Heritage Tree Ordinance. Chairman Vondra asked for a motion to accept the Barrington Hills Country Club Forest Management Plan. Crouse motioned, Mazeski seconded. All present said aye. The motion was approved.
